Leslie and Anne are not sure if this requires new procurement as the original RFP was for multi-year work. To complicate matters somewhat, 7 Mindsets has continued to work without a contract since August 2022. They are hoping to not have to do a RFP process, but for those of us present, we think new procurement may be needed to be obtained since PED did not initially fund the program to continue. Adan |

Carmen suggested Fiero and Fiero in Las Cruces. I have worked with them, and they are very good. I reached out to Mr. Fierro, and he is willing to help us get this figured out. Carmen sent me a spread sheet she had from working off and on with the Open Books Committee to provide a sense of the differences.
